General Information for the Criterium:

- If the leaders lap the field, the field is eligible for cash primes but not points or time bonuses.
- There is new pavement on the criterium course. Please be sure to review the course before you race.

Penalties

Men Pro/1

- Rider #60 is fined \$50 USD for public urination at the start of today's stage, GMSR Tech Guide pg 11.
- Riders # 73, 79 & 93 are fined \$25 USD for discarding bottles or wrappers in unapproved areas, USAC 4H14e & GMSR Tech Guide pg 9.

Women 1/2

- Rider # 141 is warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

Men 2

- Rider # 267 is fined \$70 USD for failing to obey the instructions of the commissaire, USAC 4H3
- Rider # 235 is fined \$25 USD for discarding bottles or wrappers in unapproved areas, USAC 4H14e & GMSR Tech Guide pg 9.
