From mile 15.7 to mile 16 please use caution after making the left turn onto River Road.

**Penalties**

**Men Pro/1**

- Rider #75 is disqualified from stage for center line violations USAC 3B1/GMSR Tech Guide pg 7. Rider may not start tomorrow.
- Rider #5 is disqualified from stage for discarding bottles and musette in unapproved areas USAC 4H14e/GMSR Tech Guide pg 9. Rider may not start tomorrow.
- Rider #24 is fined \$35 USD for impeding traffic after the race USAC 4H3/GMSR Tech Guide pg 13

**Women 1/2**

- Rider # 159 is warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

**Men 2**

- Rider #201 is disqualified from stage for center line violations USAC 3B1/GMSR Tech Guide pg 7. Rider may not start tomorrow.
- Rider #212 is penalized 1 minute on GC for center line violations. USAC 3B1/GMSR Tech Guide pg 7.
- Riders #206, 230, & 238 are fined \$35 USD for impeding traffic after the race USAC 4H3/GMSR Tech Guide pg 13
- Riders # 202, 257, 277, 278, & 282 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

**Men 3**

- Rider #367 is disqualified from stage for center line violations USAC 3B1/GMSR Tech Guide pg 7. Rider may not start tomorrow.
- Rider #382 is penalized 1 minute on GC for center line violations. USAC 3B1/GMSR Tech Guide pg 7.
- Riders # 322, 352, 378, & 382 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

#### **Men 4**

- Riders # 713,744, 747 & 768 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

#### **Men 4/5**

- Rider # 840 is warned for reducing the size of his body number, USAC 4H7/Tech Guide pg 10 \$20 USD fine for second offense.
- Riders # 808,834 & 867 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

#### **Juniors**

- Riders #607 is penalized 1 minute on GC for center line violations. USAC 3B1/GMSR Tech Guide pg 7.
- Rider #669 is penalized 1 minute on GC for center line violations. USAC 3B1/GMSR Tech Guide pg 7. GC currently does not reflect penalty and will be updated with Stage 3 results.
- Riders # #621 & 649 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.

#### **Men 50+**

- Rider #535 is fined \$35 USD for taking pace with another field, USAC 3B5/TGMSR Tech Guide pg 11
- Riders # #501 & 503 are warned for failing to sign in (first offense), USAC 4H4b/GMSR Tech Guide pg 11. \$20 USD fine for second offense.
